Iron Warriors Motorcycle Club Hosts 15th Annual Nebraska Law Ride

Saturday, May 13, 2023 – THIS RIDE IS OPEN TO THE PUBLIC
Omaha – Lincoln - Grand Island – Sidney – North Platte, Nebraska

The River City Chapter of the Iron Warriors Motorcycle Club is hosting the 15th Annual Nebraska Law Ride to raise awareness and funds for the perpetual upkeep of the Law Enforcement Memorial in Grand Island, NE. Along with the Americas Guardians PSMC, The Defenders LEMC and the Centurions LEMC, the motorcyclists will pay tribute to the 149 Nebraska Law Enforcement Officers who gave their lives in the line of duty. Motorcyclists will be arriving at the memorial at approximately 3:30 PM on Saturday, May 13, 2023.

The ride is open to the public and will take place rain or shine. There will be four starting locations to accommodate motorcyclists from Eastern and Western parts of the state; One group of riders will be starting at Cabela's in Sidney, NE and Budke PowerSports in North Platte, NE respectively. Riders from the eastern part of the state will be gathering at Dillon Brothers Harley-Davidson in Omaha, NE and Frontier Harley-Davidson in Lincoln, NE as their starting points. All riders will meet in Grand Island and continue to the memorial at Fonner Park. All vehicles are welcome (motorcycles and cars).
